**March 6, 2021 10:00 A.M.**

**General Meeting (via Zoom)**

President Brian Scott called the Zoom meeting to order and welcomed all in attendance. Karen Fodchuk offered the invocation and Clint Gienger lead the attendees in the International Pledge of Allegiance.

**INTRODUCTIONS:** President Brian Scott introduced the Executive Board as well as Lynne Sutton who is the parliamentarian. District Presidents then introduced their attendees.

Marty Busch made a motion to approve the agenda for this meeting. Seconded by Bob K.

**Roll call was taken and a quorum was determined.**

**SECRETARY'S REPORT:** The minutes are posted on the ASA website. Vicki Burr made a motion to accept the minutes as posted. Seconded by Linda Stoneburner.

**CORRESPONDENCE:** None

**TREASURER'S REPORT:** Treasurer Bill Smith presented a detailed treasurer's report. A hard copy of the report was provided to members, secretary and president for their records. The treasurer's report was accepted as presented. His full report is on file.

**ASA PRESIDENT'S REPORT:** President Brian Scott hopes that everyone and their families have remained healthy during this challenging year. All five districts have cancelled their inter park shuffleboard activities. All ASA special procedures, including State Championships and Awards were cancelled. Some parks continued in-park activities with Covid protocols in place. The ASA Bylaws are much like rules of the game and we must follow them. President Brian remains optimistic and with both governments rolling out the vaccination program he hopes that the 2021-2022 Season will return to normal. His complete report is on file.

A qualifying tournament in each district shall provide one doubles team entry in Championship category and one doubles team entry in Consolation category for the State Tournament, which shall be scheduled for the second Monday and Tuesday of March commencing in 2022. **Carried**
