DISTRICT PRESIDENT'S REPORTS: Full Reports on File

- **District I** - President's Report by Elmer Lang.
District I hosted the Pre-Western Tournament with 107 participants. Greenfield Village and Venture Out Resorts hosted the Western tournament with 295 participants, which included subs. Our Out-of-Park Leagues consist of 11 Teams in the Early League and 18 teams in the Late League. We had a slight membership increase and continue to encourage new players. Sylvia Smith's passing has touched the entire Shuffleboard community—here in Arizona, across the country, and around the world. Her presence meant so much, and she will be deeply missed.
- **District II** - President's Report by Kate Lof.
District II currently has 230 members, including 5 independents, which is slightly up from last year. 23 teams are participating in League play.

- **District III** - President's Report by Dale Crouch.
Membership has decreased, but we remain hopeful about adding new members. The league includes 16 parks, 5 leagues, and 26 teams.
- **District IV** - President's Report by Debra Besaw.
Two tournaments have been completed so far this season. The Snowman Classic is up next, December 15-18. League play for the 3-board Long Season has 16 teams, and the 3-board Short Season has 26 teams. The 2-board has 7 teams, which is down from last season. Etiquette and Strategy is Being Held on December 13.

League teams have been organized. Four teams participate on Mondays and four teams on Tuesdays. Membership is staying the same as last season.
